## Majlis Ansarullah UK

### General Rules Concerning The Appointment of Office Bearers

22. The following points shall be kept in view when the appointment of an office-bearer is being considered:
- He should be regular in congregational prayers.
  - He should be truthful, honest and have regard for the institutions of the Silsila Aliya Ahmadiyya and the Majlis
  - He should be regular chanda paying member of the Jama'at and the Majlis Ansarullah
    - Any member who is in arrears as regard Chandas of Majlis Ansarullah shall not be allowed to participate or vote in the elections of Majlis Ansarullah. Also such a member shall not be eligible for election or nomination as an office-bearer.
    - A member who is in arrears of obligatory chandas (viz. Chanda Aam, Chanda Jalsa Salana, Chanda Hissa Amad) for 6 months or more shall not be eligible to become an office-bearer.
    - A member who bypasses the local Jama'at system and insists to send his Chandas directly to the Markaz shall not be eligible to become an office-bearer.
    - A member against whom Jama'at took disciplinary action and a period of 3 years has not yet been completed after his pardon shall not be eligible to become an office-bearer
    - A member whose Wassiyat has been cancelled by Sadr Anjuman Ahmadiyya by the way of disciplinary action or due to none payment of Chanda Wassiyat shall not be eligible to become an office-bearer.
    - A person whoever brought Jama'at funds or Auxillary organization funds into personal use shall be liable to reimburse the used amount and shall not be eligible to be elected or nominated to any office for a period of 3 years after the reimbursement of the used amount and pardoned by Hadhrat Khalifatul Masih.
  - If a person is subjected to any disciplinary action a second time he shall never again be eligible to hold any office.
  - He should observe the Islamic Sha'a'ir viz. He should have beard. In case of an exception it shall be necessary to obtain permission from Sadr Majlis.
23. The names of all the elected or nominated office-bearers shall be submitted to the Sadr Majlis for approval. The Sadr Majlis shall nominate members of National Majlis-e-Amila and seek approval from Hadhrat Khalifatul Masih.
24. A person whose election or nomination for a particular office is rejected shall not be eligible for re-election or re-nomination for a period extending up to the end of that term.
25. No person shall be elected to the same office for more than 3 consecutive terms. However, Hadhrat Khalifatul Masih may waive off this condition in case of Sadr Majlis or Na' ib Sadr Saf Dom. The Sadr Majlis may waive off this condition in case of the other office-bearers.
26. The incumbent office-bearers shall continue to function till the approval of the new election or the new nomination is received.
27. All the elections shall be open (e.g., by show of hands).
28. Any type of propaganda or canvassing implicit or explicit is not allowed in the elections.

29. The quorum for an election meeting shall be one half of the total members **eligible to vote vide rule No. 22** of the Majlis concerned. If the quorum is short at the time of first election meeting and it has to be postponed, the quorum for the next meeting shall be one third of the total members of the Majlis concerned.
30. A person who is appointed to a higher office by election or nomination shall not be eligible to retain a lower office as well, unless the Sadr Majlis exempts someone from this rule.
31. All the elections shall be completed by the end of Fatah/December unless:
  - a. The headquarters direct otherwise.
  - b. Permission is obtained from Sadr Majlis to delay the election for a specific period.
32. It is necessary that a complete report of the proceedings of every election meeting is submitted to the Sadr Majlis (for obtaining his approval concerning the appointment of office-bearers) and this report should include all the names proposed along with the names of the proposer, the seconder and the votes obtained by each nominee.
33. The age of all office-bearers of Saf Dom (except the Na'ib Sadr Saf Dom) shall be between 40 to 50 years.

Hadhrat Khalifatul Masih V (atba) has given approval to include the following new rules:

- a) A Nasir who is in arrears of Chanda Majlis Ansarullah for more than 6 months, and of Chanda Salana Ijtima for more than 1 year shall not be eligible to hold any office of Majlis Ansarullah.
- b) A Nasir who is in arrears of Obligatory Chandas (viz. Chanda Aam, Chanda Hissa Amad for more than 6 months, and of Chanda Jalsa Salana for more than 1 year) shall not be eligible to hold any office of Majlis Ansarullah.
